Wawasee Community School Corporation Pathways Director Vince Beasley presented to the Board. Mr. Beasley started the report showing a promotional video showcasing various programs. There are approximately 300 students taking CTE Classes. There are 15 programs available for students to choose from. The goal is for our students to be work ready and employable. These classes are elective classes, with students having to apply to get in, so they are generally excited to be in those classes. Pathways receives a lot of support from the community, Central Office and the Board. Scholarships are available for students who may have trouble paying the fees. Coming up next year, the CNA Class will add an afternoon session to their schedule and a CNC Machining Class will be offered and held at Polywood for students.

Under the Superintendent's report, Dr. Tom Edington reported that \$25,000 from the sale of the former Syracuse Elementary was placed in the Wawasee Community Schools Education Foundation. This will be used for Teacher Grants. Applications are due mid-March and will be used for projects next year. The Education Foundation Committee is made up of principals, administrators, community members and parents. Randy Carpenter has joined the Wawasee Middle School Administration as interim Principal. Mr. Carpenter and Mr. Brent Berkeypile will handle the day to day operation and administrative duties at WMS for the remaining 2019-20 school year. The Administrative opening timeline for the Director of Curriculum and Instruction has been set and hope to bring a recommendation to the board in March. The Wawasee Middle School Principal position will be posted around March 1st. WMS and WHS had an eLearning day last week because of higher absence rates due to sickness. Each school was deep cleaned while students were out, along with the buses. Absence rates seem pretty normal as of today. March 3 a group of teachers, community members and administrators will be traveling to Indianapolis to talk to legislators. Elizabeth Smart is coming to speak in Warsaw on April 23. We will be taking some students that we feel could benefit from hearing her story. There have been some upgrades to the ventilation system at WMS in the pool area. The process of looking for the next cycle of one-to-one devices has started and there are hopes to bring those ideas to the Board soon. There have been two community presentations on the Opioid Crisis and they have been very well attended. Several counties have received grants to provide broadband access to areas of the county where it is needed. Kosciusko County is one of those counties. Wawasee Schools also have Hot Spots for students that do not have internet access. The 2020 Tax Rate is at .55 cents. Bids are due February 19 for the spring and summer projects. We are excited to get started on the projects. The Wawasee Drama Department is having a fundraiser at Texas Roadhouse in Warsaw, on February 18. The spring production of "The Beauty and the Beast" is set for March 27, 28 and 29.

There were no Other Items.
