Mr. Pat Terrell of the Winston Terrell Group reported to the Board. The Winston Terrell Group has helped more than 60 school districts in the state work with state school referendums. Should a school decide to pursue a referendum, it becomes a political campaign and the candidate is a "thing", not a person. A political action committee made up of local community members will be formed and begin campaigning immediately up until the November election when a question will be placed on ballots, if the board decides to proceed with the referendum process.

Mr. Rob Fisher moved to continue to work with Winston Terrell Group and Mr. Mike Wilson seconded the motion. The motion carried 3-0.

Dr. Steve Troyer presented his Student Learning Report. Summer School will begin for K-8 students on July 20, 2020 and run through August 7, 2020 at Syracuse Elementary. This will be in-person classes. There are currently 152 students for K-8. 9-12 students have finished one session of Summer School, online format and will be starting a second online session on July 20. Summer School will be a sort of trial run for our health protocols for the fall. United Way has partnered with us to "Start United", as a way to increase participation, and provide Ready to Go Bags with books and supplies for the students. The CARES Act Application has been submitted for our corporation and is awaiting approval.

The board heard the 2020-2021 Wawasee Back to School Plan, presented by Dr. Troyer. Families will be asked to do at-home health screening following a checklist. Hand washing protocols will be developed for each classroom and building for critical times and hand sanitizer will be available in each classroom along with high traffic areas throughout the schools. It is recommended students wear a mask, but they will be able to remove masks in the classroom. Students are strongly encouraged to wear masks in hallways, restrooms and in other common areas. Masks are required on school buses, in health clinics and where space is limited. Students and staff will be provided masks and disposable masks will be available when needed. Until further notice, all schools will open 30 minutes later than normal each day to allow time for targeted cleaning and for staff to work with students who are involved with remote learning. Visitors will be limited to the front office area of each building until further notice. Field trips and convocations will not be scheduled and public events and programs will be evaluated on an individual basis, but may be restricted. Families who do not feel comfortable sending their students back to school will be given an online option for learning, but are asked to make a commitment for at least one trimester. Registration for the online option should be made by July 31, 2020, to allow for proper staff and resources.

Mr. Mike Wilson moved to accept the 2020-2021 Wawasee Back to School Plan. Mr. Rob Fisher seconded the motion. The motion carried 3-0.

Mr. Mike Wilson moved to accept Additional Action Items a, b, c, f and g, with a change on the Transfer Resolution HB1009, which should read \$250,000, not \$1,000,000. The change is reflected on the signed form. Mr. Rob Fisher seconded the motion and changes. The motion carried 3-0. Additional Action Items included:
