Mrs. Mary Lou Dixon moved to accept the Referendum Tax Levy Resolution 2020-004. Mr. Rob Fisher seconded the motion. The motion carried 5-0.

The question on the November 3, 2020 ballot will be: "For the eight (8) calendar years immediately following the holding of the referendum, shall Wawasee Community School Corporation impose a property tax rate that does not exceed twenty-eight and five tenths cents (\$0.285) on each one hundred dollars (\$100) of assessed valuation and that is in addition to all other property taxes imposed by the school corporation for the purpose of funding the expansion of safety and security measures, and the retention and expansion of school programming and instruction, including career-and-technical education and adult education?"

Wawasee Community School Corporation is the lowest tax rate in our region and the lowest in the state of Indiana. With the anticipated state budget cuts, we would still be the lowest tax rate in the state.

In Other Items, Dr. Edington thanked Phil Huffman and Jeremy VanLue for their help with Wawasee High School Graduation. It was a great day for our seniors.

Mr. Mike Wilson moved to adjourn. Mrs. Mary Lou Dixon seconded the motion. The motion carried 5-0.
