The Student Learning Report was submitted by Joy Goshert. 21 students are taking IREAD-3 remediation in June with 4 teachers. They will retest the week of June 17. ECO Challenge is June 10-July 26, but only meet Monday the week of July 4th. ECO meets 9am – 2pm each day. We have 36 students enrolled. Middle School and High School courses are being held at Wawasee High School, June 3-8. We have 40 middle school students, 61 high school students that are taking courses at the school through Apex Digital Learning and 35 high school students taking English credit recovery. Elementary summer school is held at Syracuse Elementary, June 3-21, and there are 27 Kindergarten Countdown students. New Certified Staff Orientation is August 5-9, 2019.

In the Superintendent's Report, Dr. Edington reported the solar panel installation for the Bus Garage and Wawasee High School are nearly complete, but not hooked up yet. The panels have been delivered for Wawasee Middle School and will be installed next. Syracuse Elementary, Milford and North Webster School will follow. NIPSCO trimmed a large tree at Milford School, but the tree may need to be removed. Trauma Training is moving along well with approximately 50% of staff trained. Remaining staff will continue to train over the summer and we hope to be finished before school starts. WMS had a fire panel that was not working, so fire walkers were in the building until everything was fixed and hooked back up. The panel alerts emergency staff to where there may be a fire, if one breaks out. The retention pond at Wawasee Middle School was not draining and going down, so we had someone clean out the tile. Tree roots have caused this and some trees may have to be removed to help the pond drain. We are working on staffing and still have openings. The Corporation Nurse submitted the Health Services End of the Year report. Our school clinics saw 18,500 students this year. They also held immunization clinics and plan to continue this next year.

In Other Items, there will be an Executive Session on June 18, 2019 at 5:00pm in the Conference Room at Central Office. The July Board Meeting is July 9, 2019 in the Warrior Room. There will be a Budget Workshop on July 30, 2019 at 5:00pm with a Budget Retreat to follow at 5:30pm.

Mr. Mike Wilson moved to adjourn. Mrs. Mary Lou Dixon seconded the motion. The motion carried 4-0.
