• Codey Holliday is recommended by Kim Nguyen as a Wawasee High School Temporary Art Teacher. This position has a start date of February 15, 2017 through the end of the 2016-2017 school year.

Mrs. Joy Goshert presented the student learning report. She asked Mr. Shawn Johnson to present the 2015-2016 school report card letter grades. He reported that the letter grades that are given out by the Indiana Department of Education are only calculated based on ISTEP scores, except for the high school grade. For the 2015-2016 school year, all five of Wawasee schools received a letter grade of "C". Wawasee Community School Corporation also uses multiple measures to create a letter grade for each school. Using multiple measures creates a more accurate and more encompassing reflection of the schools. Some of the measures that are taken into account are attendance, both staff and student, NWEA scores, special education and free and reduced percentages, as well as other factors. When using this multi-measure approach, Milford Elementary and Syracuse Elementary school have an assigned letter grade of "A". North Webster Elementary, Wawasee Middle School, Milford Middle School, and Wawasee High School are assigned a letter grade of "B". Mrs. Joy Goshert continued the student learning report with a reminder that the ISTEP practice window is now open. The actual testing window opens on Febrary 27, 2017. Five-Star Technology continues to work with our schools to make sure that Wawasee is integrating 1:1 technology appropriately. Mrs. Goshert offered a reminder to the board that the AdvancEd District Accreditation Visit would begin on Sunday, March 19, 2017 and the exit report would happen at noon on Wednesday, March 22, 2017.

Mr. Eric Speicher presented his school improvement plan report for Syracuse Elementary School. He presented to the board the current demographic make-up of the students at Syracuse Elementary School and the current goals of Syracuse Elementary School. Goals of Syracuse Elementary School include improved comprehension of and response to reading across the curriculum, using mathematical skills to think critically and apply knowledge and reason to solve problems, and engaging students and enhancing their learning experiences through the integration of technology. The achievement of these goals will be measured by NWEA RIT data and ISTEP passing rates. Some of the action steps that the school is taking to aid in meeting these goals are to provide high quality instruction and use the 1:1 technology to incorporate technology into instruction.
