This summer there were also classes offered for middle school students at both Wawasee Middle School and Milford Middle School and classes for students entering grades 4-5 which focused on math and language arts skills. Wawasee once again partnered with United Way of Kosciusko County to offer Kindergarten Countdown to those students in our area that did not have the opportunity to attend pre-school to be able to get them familiar with the school setting. We are transitioning one of our teachers into the All Write Director position and will become the fiscal agent/pass through for the consortium at the end of the 2017-2018 school year.

In other items, Mr. James Flecker addressed the board with an update on the Syracuse Elementary School construction. He stated that possession of the building took place on July 5, 2017 with the move starting on July 7, 2017. The move from the old elementary to the new elementary is about 80 % complete and the technology is currently being installed. Mrs. Linnemeier also mentioned that there is a regional IDOE meeting with state superintendent, Jennifer McCormick on September 13, 2017 at a place that is yet to be determined. There will be more information to come at a later date.
