Mrs. Rebecca Linnemeier welcomed everyone and called the meeting to order at 5:32 p.m.

Mrs. Linnemeier asked if there were any patron comments. There were no patron comments heard.

Mrs. Mercedes Pratt, Milford Physical Education Teacher presented to the board, the Heart Zones System, purchased through a K21 Grant. Mrs. Pratt received funds to implement this program in all of our elementary schools. At the start of each Physical Education Class, every student puts on a monitor and data starts to be collected. The results are projected on the walls of the gym so each student can see where they are, in terms of their activity goal, as the class progresses. The students adjust their activity to stay in the Moderate to Vigorous Physical Activity Zone. The data collected showed the students at Milford School achieved the higher end of the daily goal in the first six weeks. Mrs. Pratt brought monitors for the board members to put on, to see how they work. The system will also be programmed to show calories burned, and record other health data. Mrs. Pratt is currently setting up the system to send fitness reports to parents of students.

Mr. Tye Bloomfield presented on The Work Ethic Certificate. Wawasee Community Schools are hoping this Certification will motivate those students who may not be college bound. The program also gives employers a chance to get the employees they want. To earn The Work Ethic Certificate, there are two rounds of Criteria, including Attendance, Tardies, Discipline, GPA and Community Service/Internships. After earning the Certificate, local employers offer incentives to students with the Certification, such as a guaranteed interview or a bump in hourly pay. Names of students who complete the criteria are turned into the state and the Governor signs the Certificate. 40 of our students have passed Round 1 Criteria. Wawasee's goal is to have 10 local businesses as part of the program. Next year the program will be introduced to all of our students. Mr. James Flecker the possibility of having a banquet, using Culinary Arts, to showcase and recognize the businesses and students, and bring more attention to the program.
