Mrs. Joy Goshert presented the Student Learning Report. She reported further on the DEKKO Fostering Innovation and Inquiry grant. With the oney from that grant Wawasee will be hiring two Instructional Coaches and realigning the current Instructional Coaches. There will also be work with Buck Institute for Education that include training days for administrators, student services coordinators, instructional coaches, and some teachers. Mrs. Goshert also reported on the Project Lead the Way Launch. There will be training provided for staff representatives from each elementary school and it will blend well with project based learning. Mrs. Goshert presented the Student Health Services Report on behalf on Myra Alexander. The health services professionals at each school have been busy and a part of many students and staff well-being for the 2015-2016 school year.

Mr. Rob Fisher moved to accept the Additional Action Items a.-f. including laydowns of reassignment of ADA Coordinator, Title IX, and Section 504 responsibilities, as well as a grant easement for natural gas service from NIPSCO for the new Sryacuse Elementary School. Mr. Mike Wilson moved to accept Additional Action Item g. Mr. George Gilbert seconded the motion. The motion carried 5-0. Additional Action Item g. included:

- g. Hearing on Project and Second Amendment to Lease Mr. James Flecker commented that this hearing was being held on the refinancing of bonds for North Webster School. The refinancing of the bonds would lower the interest rate and not result in higher payments for the bonds.

Dr. Tom Edington addressed the board with the Superintendent's report. The Superintendent's report included the following:

- a. Graduation Report Dr. Edington reported that all went well.
- b. Health Care Occupations Summer Camp Mrs. Cindy Kaiser reported that she sent several 7<sup>th</sup> grade students to a two day health care summer camp.
- c. Lunch Program Audit Mrs. Amanda Jackson reported on the Lunch Program Audit. Wawasee Schools is audited every 2-3 years. Overall, the audit went well. They had no concerns with the site that they chose to visit for food preparation, nutritional content, or safety plan. They did have concerns with the lack of documentation and consistency with the free and reduced meal price applications as well as the fact that the hot lunch fund balance is over three months operating expenses. Plans are in place ro correct these issues.
- d. Construction Report Mr. Bob Lahrman reported that the new Syracuse Elementary continues to be ahead of schedule. He also that the Milford School, Site, and High School projects are progressing as planned.
- e. Climate Audit Plans/Timeline Dr. Edington noted that the board had met with the gentlemen who did the Climate Audit for Wawasee Schools. Based off of that meeting, a timeline will be put into place to come up with a plan for Wawasee Schools.

In other items, Dr. Edington noted that the timeline to start negotiations for teacher agreements has been moved to August 1, 2016. He also noted that George Gilbert submitted his resignation from the Wawasee Community School Corporation School Board of Trustees. This resignation will be effective as of July 12, 2016. He is an At-Large member and would need to be replaced by an At-Large member from the Jefferson East, Van Buren, or Turkey Creek township.

Mr. George Gilbert moved to adjourn. Mr. Rob Fisher seconded the motion. The motion carried 5-0. The meeting was adjourned at 6:32 p.m.
