Mrs. Joy Goshert presented the Student Learning Report. She asked Ms. Rikki McCann and students to present to the school board about the 2017 Wawasee High School Spanish class student trip to Costa Rica. The students were able to experience Costa Rica in a variety of ways. They experienced the history along with the culture. They were able to attend a school within Costa Rica and meet students at that school that they still connect with after returning home. Mrs. Goshert presented to the board a state assessment update. There is currently a call out for educators to serve on ILEARN Assessment Committees which is the new Indiana assessment slated to be given during the 2018-2019 school year. The board was presented with an updated guidance for state assessments for math testing and what the updated guidance will mean for this year's math students as well as in the future. Included in the report was data on the retesting for students not passing Spring 2017 ISTEP English 10 ELA and/or Math. Mrs. Goshert also updated the school board on the plan for eLearning Days for Inclement Weather. Staff is preparing by practicing these type of days during SMART Starts. Students are also practicing for these days during school hours. There will be a website and parent communication to aid parents during these days.

Dr. Sandra Weaver presented to the board on the Student Assistance Plan Usage. The Student Assistance Plan for Wawasee students is in conjunction with Bowen Center. Bowen Center currently offers 2 free sessions for each Wawasee student. This program is used in a variety of ways across our district for students. The usage for students crosses all age groups and demographics. This is a great partnership that has a high value to the school corporation. The goals of the program moving forward is to remind families that the service is available.

The motion passed 5-0. Dr. Edington also reported on the implementation of Raptor Safe School System. This system is supposed to be implemented within our schools by October 1, 2017. During the report he also noted that he had the opportunity to speak at a health care summit held at Goshen Hospital to promote the wellness program that we have in place for Wawasee School staff members. Dr. Edington noted that the IHSAA is looking across the state at the "Win at All Costs" approach. The memorial area of the high school football field has been relocated and new boulder with plaque purchased. A memorial time will be held at a future football game to dedicate the new area.
