Mrs. Joy Goshert presented the Student Learning Report. She asked Ms. Sara Harrison to update the board on the technology department and the 1:1 project. Ms. Harrison reported on the Roll Out plan for the 1:1 devices in early August. The cases for the devices are on order and they are waiting on the shipment of them. The hardware for all computers in the district is being updated and the computers are being re-imaged to Windows 10. There are device management systems being added to allow teachers more control of the use of the devices within their classrooms. Much work is being done to the infrastructure at all schools. This will enable the devices to work and have good signal strength in all parts of the buildings. Mr. Mike Wilson asked if there would be testing done for each classroom to ensure that all is working properly. Ms. Harrison confirmed that there would be testing and some of the testing is already done. There are many opportunities for professional development, both in a group setting and on-line being offered. There are good questions being presented and answered. The Tech Center at Wawasee High School is being remodeled. The changes being made will be a great improvement on space for the department. In other news, the Spring 2016 ISTEP+ results are available. There were a few glitches with the timeline that was originally given from the state. Mrs. Goshert is in the process of drafting an e-mail to parents to help with the log-in to the new Pearson Testing system and give instructions on how to request a re-score. Mrs. Goshert presented the board with the new teacher orientation for the upcoming school year. She also updated the board on the United Way Day of Action. Both DePuy-Synthes and the Bowen Center had teams that came down and assisted in sprucing up three of the corporation's buildings and grounds. A big "Thank You" is owed to all that helped. Mrs. Goshert also reported that on-line registration is going to be delayed a week and will start on July 25, 2016. This is due to a delay in the Skyward End-of-the-Year Roll Over.

Mr. Mike Lindsey, Performance Services, presented to the board the annual energy savings report. He reported that this is the five year mark for the program. In those five years there was a total guaranteed energy savings of \$944,175. There was an actual savings of \$1,152,403. All 5 of the distict schools are in the top 25% of energy performers nationally for school districts. There will be some changes and adjustments for the 2016-2017 school year. The cost savings will continue to grow and the program standards will get a new start.

Mrs. Linnemeier reported to the board on Additional Action Item h. Board of School Trustees Vacancy. She reported that Wawasee Community School Corporation Board of School Trustees was given the task of finding a replacement of a board member for Mr. George Gilbert who has resigned his duties as a Wawasee Community School Corporation Board of School Trustees member. His over 30 years of educational experience and well thought out decision making will be missed. Through the Board of School Trustees review of resumes, they have chosen a candidate that they feel embodies the mission of the school and will work well with the Board of School Trustees. As a result of this search, the Wawasee Community School Corporation Board of School Trustees has nominated Don Bokhart for this position. Mr. Bokhart has 37 years of experience within education and school administration. August 2, 2016 will be the first meeting that he will be attending and will take his Oath of Office at that meeting.

Dr. Tom Edington addressed the board with the Superintendent's report. He asked Mr. James Flecker to update the board on the construction projects throughout the district. He provided an update on the Syracuse Elementary construction. The contractors continue to be ahead of and on schedule. There are also projects at Wawasee High School, Milford School, and the Bus Garage that are on-going.

In other items, Mrs. Linnemeier noted that there is new teacher orientation starting on August 1, 2016. The board members are welcome to attend that morning starting at 8:00 am if they wish. She also noted that she is on the legislative committee for the ISBA and had a meeting on June 25, 2016 that she attended.
