Mrs. Joy Goshert presented the Student Learning Report. She reported to the school board that classified staff have been notified that they will receive their pay for eLearning days. It will be the department supervisor's responsibility to work with the groups and make sure time is made up. Mrs. Goshert also reported to the board that she and Dave VanLue, Director of Technology, attended a focus forum on December 5th and 6th. The forum was put on by the Indiana eLearning Leadership Cadre and Central Indiana Education Service Center. There was time to discuss eLearning and the effects that technology has on school communities. She also noted that ISTEP retakes were held the week of December 4-8.

Mrs. Susan Mishler presented to the board the School Improvement Plan for Wawasee Middle School. She presented to the school board an overview of Wawasee Middle School goals along with a professional development plan.

Under the Superintendent's report, Dr. Tom Edington noted that Wawasee Schools has raised the pay of retired teachers that are acting as substitute teachers. This was approved at last month's school board meeting. He also reported that Wawasee High School is going to have a trial period of a teacher leave bank. This teacher leave bank would encompass teachers that are covering for other absent teachers during their prep time. Wawasee Transportation Department is in the process of using and continuing to install stop arm cameras on school buses. The cameras have been used to catch several individuals. However, no tickets have been issued to this point. The next school board meeting for reorganization will be held on January 9, 2017 at the new welding building. The next regular school board meeting will be held on January 16, 2017. Dr. Edington also reported that he and Mr. Nguyen attended the State Board of Education meeting where they passed the new graduation pathways. He noted that many people spoke in opposition of the new plan. The new graduation pathways is being done to raise standards but leaves many students without other options as it eliminates a general diploma option.
