She also reported the department is very involved with students as not just the first reponders at the schools but, also managing chronic illness such as diabetes, asthma, and other. Mrs. Goshert then continued her board report with a report to the board on school safety items. She reported that school safety plans are updated at the start of each school year and are specific to both the school and the students attending the school that have special needs. The Indiana Department of Education will be conducting audits of the school safety plans during this school year. Mrs. Goshert also presented that several staff members in the corporation will be attending School Safety Specialist Basic Level Training during this school year. With the addition of those attending Basic Training, there will be 12 certified school safety specialists within the corporation. Finishing her Student Learning Report, Mrs. Goshert stated that during the month of October, the school corporation has partnered with Bowen Center to provide suicide prevention training to staff members
